How to Set Up for a Meeting via Zoom:

Zoom is a computer program used to hold online virtual meetings. You can use Zoom on a smartphone, a tablet, a laptop, or a desktop computer (as long as you have a camera, speakers, and a microphone). It uses your computers or phone's camera to show live video of all attendees (if you don't want to be on camera, that's fine, too. You can just display your name). Zoom uses your computers or phone's microphone to let you talk to other meeting participants.

- <u>Step 1.</u> If you wish to attend the AGM via Zoom, you need to first advise the MiVAC Secretary <u>Secretary@mivac.org.au</u> by email to of the email address which you want your Zoom invitation to be sent to. You need to do this by 10 September 2022.
- <u>Step 2.</u> You must download this program from the Zoom website to your computer, phone, or tablet ideally no later than the day before the AGM.
- **Step 3.** The Chairperson will email you an invitation to join the Zoom meeting,
- <u>Step 4</u>. After you install Zoom, there are a few different ways to join a Zoom meeting. You can click the link in your invitation email or go to the Zoom website and enter the meeting ID that you will receive in your invitation email.
